## **Begin Your Career in Law at NJIT**

As technology-related cases continue to increase in areas such as intellectual property, information literacy, and environmental and health issues, attorneys with a background in technology are in demand. To meet that demand, New Jersey Institute of Technology offers three exciting undergraduate options:

- A four-year, pre-professional bachelor of arts degree in Law, Technology and Culture (LTC), followed by application to law school
- A four-year bachelor's degree in any NJIT major along with a minor in Legal Studies, followed by application to law school
- An accelerated program offered jointly with Seton Hall University School of Law which enables exceptionally well qualified students to earn both the Bachelor's and Law degrees in just six years.



## **Four-Year Program**

Students pursuing the four-year Law, Technology and Culture degree are trained in a unique, interdisciplinary program that draws upon the strengths of NJIT's technology-related fields. The program features a dynamic array of courses such as Law and Society in History, Legal Issues in Media History, Legal Issues in Environmental History, Information Technology and the Law, and Legal Aspects of Engineering. Although admission to the Albert Dorman Honors College is not required, the rigorous curriculum in the LTC major is intended mainly for honors students. Alternatively, students may earn a bachelor's degree in any NJIT major while fulfilling a minor in Legal Studies. Both LTC majors and Legal Studies minors prepare for law school under the expert guidance of the LTC Director, and students with degrees in science or engineering can take a special course of study to prepare for careers in patent law.

## **Accelerated Program with Seton Hall University School of Law**

- Students with records of outstanding accomplishment in high school may apply to the accelerated six-year program, which requires acceptance into the Albert Dorman Honors College. Students apply to NJIT, the Honors College, and the accelerated program with one application form, submitted by January 15. The Honors College recommends the best applicants to Seton Hall University School of Law.
- Seton Hall University School of Law chooses to interview some of the recommended applicants and makes the final decision on acceptance into the accelerated program.

Students in the program attend NJIT for three years, fulfilling all NJIT and Honors College requirements. The remaining three years of the six-year program are spent at Seton Hall University School of Law. Applicants to the Accelerated Program must have a minimum SAT-I composite score of 1300 (Critical Reading + Math) and top 10% rank in class. For students entering the Accelerated Program after the first year at NJIT, performance in first-year course work at NJIT will also be taken into consideration. Students may choose from among many majors in addition to Law, Technology and Culture for accelerated programs. Summer courses may be required. The LSAT must be taken in the third year, and a score at the 80th percentile must be obtained for admission to Seton Hall University School of Law.

## There is an early application deadline — January 15 — for the accelerated program.

The accelerated program is available to outstanding seniors in U.S. high schools who will be United States citizens or permanent residents at the time of their entry into law school. Students may also apply during or immediately after their first year at NJIT.
